<u>District Representative Report for Assembly May 1 - 3, 2015</u>

District 4 (East Volusia, East Putnam, Flagler, St. John's Counties)

District 4 continues to hold its business meeting on the third Saturday of each month at the Learning Center of Santa Maria Catholic Church in Flagler Beach. All are welcomed. It is scheduled from 10 a.m. to noon-ish. We observe a 10-minute break at 11 a.m. and resume with a spiritual share by a member; light refreshments are served. Attendance has increased to 22 – 28 range; I see many new faces and an eagerness to participate, to learn, and to grow in service.

Always trying to pump life into these meetings, D4 has implemented a "10 - minute GR Shout Out" where the GRs discuss anything they wish, Al-Anon related, of course. So far, the topics have been related to how to present business announcements at meetings; how often and how much to donate and to whom; and next month the request is for information about a prudent reserve.

Two new GRs hosted our annual Day of Workshops on April 11 in Flagler Beach. By all counts, it was a success. Each GR had gotten their home groups involved in its execution. Three workshops, one dynamite speaker, a buffet lunch, a basket raffle, LDC table, and a skit kept approximately 40 attendees well Al-Anon-ized! FYI...during one of the workshops, there was a shortage of tissue boxes to pass for tear-drying.

District 4 GRs have voted and will be buying liability insurance to cover all of its 30 or so individual meetings, its 12 monthly business meetings, and 3 annual events. Since this is an unexpected expense, D4 will create and send an appeal letter out to all active groups asking for a separate donation to help offset this substantial, new budget item.

Our public outreach chairs have been busy: D4 continues to support 2 institution meetings by providing CAL and Al-Anon members to participate during these meetings. Each meeting is creating a library of new and slightly-used CAL for its members to borrow (library-style) and each new meeting attendee receives a new-comer packet. Public outreach has been asked to attend and speak at a meeting hosted by Flagler County Schools; and public outreach will also participate in a Recovery Event in Daytona Beach in September 2015, distributing Where n When's, AFA's, and assorted Al-Anon pamphlets (practicing attraction rather than promotion).
