### 1. AMIAS Requirements and Authorized District Signers

I heard a consensus that all AMIAS Requirements must be followed even if one does not like some of them.

This embodies many of our principles, including Responsibility, Respect and Consistency. It is most important to note that since the 2003 WSO Alateen Motion, Alateen is the one place in Al-Anon with Rules. WSO and Area discussed, voted and approved a number of rules to protect Alateens and Al-Anon for our own SAFETY.


I, for one, believe our requirements are overdue for review and update.
