It is with great pleasure that the Board of Trustees, Al-Anon Family Groups, Inc. announces that on September 5th, 2017, Vali F. will begin her tenure as our next Executive Director. Vali brings with her over 15 years as an active Al-Anon member. She served as a Panel 53 Delegate from Arizona, Area Chair, Secretary and Treasurer. Additional Al-Anon service roles include AIS Chair and Alateen Coordinator. Vali also brings over 20 years of business experience including management of teams of staff throughout the world. Vali has a keen understanding of the world's ever-changing landscape and how those changes have and will continue to impact the growth and diversity of our fellowship. Vali fully embraces the continued need to find new ways to reach those whose lives have been affected by someone else's drinking. Our current Executive Director, Mary G., has committed to working side-by-side with Vali beginning September 5th through the October Board meeting. This transition period will ensure that our new Executive Director, our World Service Office (WSO) staff and our fellowship as a whole experience a smooth transition. As shared in the April 2017 Chairperson of the Board Letter, the Board believes this transition period is supported by the spiritual principles of our program by offering the sharing of our experience, strength and hope. We then let go and allow the new Executive Director the freedom to oversee the World Service Office in her own way as outlined in Concept Eleven.

WSO Finance Committee Update

This is an update from the finance committee to delegates July 24, 2017.

As you will read in the Chairman of the Board July Letter Finance update, Literature Sales are a little over budget at the six-month mark **but Contributions are falling a little short of target**. Your message after Conference in 2016 resulted in a significant increase in Contributions but we did not see that bump this year, which caused the Finance Committee some concern. We were wondering if we, as presenters at the Conference, did not adequately convey to you the ongoing financial needs of AFG Inc.

As you know, we built our 2017 budget based on a projected \$2,100,000 in Contributions. As you remember, the abundance realized in 2016 allowed us to

make significant investments in technology. We have brought much of the work in-house, resulting in the near completion of our completely re-worked website, a Conference app, improved communication applications and hints and promises of great things to be unveiled in the very near future.

All these improvements and more are dependent on the message being carried that there is still a great need for support of the operations of the World Service Office. Last year's abundant and unexpected response was a direct result of your effectiveness in carrying that message to the fellowship.

Please also express our gratitude to your Areas. In addition, please also continue to keep them aware of the need that is as great, or perhaps even greater than last year.

The following update is based on the unaudited financial statements for the period ended June 30, 2017: The General Fund recorded a loss of \$10,349 for this period, compared to a gain of \$341,931 this period last year. That represents a net negative of \$352,280 over this period last year.

This is mainly due to full staffing in the office this year, which was not the case last year. It is also reflective of the amazing bump in Contributions this time last year after the World Service Conference.

Revenue from literature sales was slightly above that of 2016, and is tracking ahead of budgeted expectations. The General Fund investment income totaled about \$27,000. We are hopeful that Contributions and Sales increases will allow us to grow the Reserve Fund by not transferring funds from the Reserve Fund to the General Fund.

Income: Literature sales were \$1,899,251 for this period, compared to \$1,845,798 at this time last year, Gross profit on literature sales was \$1,506,554 (81% of sales), compared to \$1,495,171 for 2016.

Contributions are at \$1,015,231 for 2017, compared to \$918,718 last year—an increase of 10.5% but falling a little short of budgeted projections.

Forum subscription income was \$134,767 for 2017, an increase of 13%.

Expenses: Actual operating expenses were \$2,709,426 for the first six months of 2017, compared to \$2,321,645 last year and slightly over budget.

Full staffing, notably in the Digital Strategy Department, is reflected in the increased expenditure over last year.

Reserve Fund: The fair value of investments in the Reserve Fund totaled \$5,585,360 at June 30, 2017, an increase in value of over \$400,000.

Outlook: While Contributions dipped a bit in the month of June, we are hopeful that the abundance demonstrated in 2016 will carry on in 2017. That level of participation, along with some encouraging Literature Sales numbers will allow the World Service Office to continue to support all the members carrying the message of help and hope.

Board of Trustees (BOT)

One of the most enjoyable and enlightening parts of being a Delegate has been to further understand the role of the BOT. We are blessed to have these wonderful members who give their time, experience, strength and hope to ensure the future of Al-Anon.

The World Service Office (WSO) is comprised of paid staff and volunteers, some who are Al-Anon members that provide services to our membership, many functions and activities of the fellowship circulate through this office. It is the center not the head; it serves but does not control or direct.

The Trustees, along with members of the Executive Committee, direct business operations of the World Service Office, observing the By-Laws of Al-Anon Family Group Headquarters, Inc. The Board acts as the chief service arm of the World Service Conference as it guards the legal rights of the Al-Anon fellowship and controls the finances. The Board serves as guardian of our Twelve Traditions, our Twelve Concepts of Service, and the Al-Anon World Service Conference Charter.

To aid in members' better understanding of the actions and duties of the Board of Trustees, it is important to know that Trustees, Executive Committee members, and employed staff have a fiduciary duty to the organization of AFG, Inc., including duties of Care, Loyalty, Obedience, and Foresight. In short, this means they are required to act reasonably, prudently, in the best interests of the organization, to avoid negligence and fraud, to avoid conflicts of interest, and to look continuously into the future.

Strategic planning for Al-Anon began in the 1990s. The Strategic Plan is connected to the Vision and Mission and is the plan for how the Vision and Mission will be

carried out. The Board of Trustees strives to have its work focused on 80 percent forward thinking toward Al-Anon's future.

BOARD VISION STATEMENT All people affected by someone else's drinking will find help and recovery in every community.

BOARD MISSION STATEMENT Anticipate the future and Al-Anon's place in it and ensure that the necessary resources are available.

STRATEGIC PLAN PRIORITIES Al-Anon's spiritual principles permeate our policies and practices; we apply emerging technology and communication options:

- To increase the visibility of Al-Anon so that it is recognized as the number one resource throughout the world for helping friends and families of alcoholics

Registration information is being finalized and will be available on our Members' website and mailed directly to registered groups by mid-September.

2018 World Service Conference

The 2018 Word Service Conference will be held in West Harrison, New York Monday April 16-Friday April 20th 2018. The site will allow the opportunity for the full Conference to visit Stepping Stones.

The Conference Leadership Team (CLT) recommended and the Board and is pleased to announce the approval of the 2018 World Service Conference theme:

Al-Anon – There is no standing still!

Al-Anon – ¡No hay razón para detenerse!

Al-Anon – Il n'y a pas de place pour l'immobilisme!

This theme, an excerpt from a statement made by our co-founder Lois W., is both a reminder and a call to action for every member. Al-Anon must continue to grow if it is going to fulfill its primary purpose of reaching millions who need Al-Anon's help but are not yet aware of the existence of our fellowship.

Policy Update

The purpose of the update sent each quarter by the Chair of the Policy Committee is to provide information and report progress regarding the following:

- Topics discussed by the Policy Committee that are generated by the fellowship and need clarification or interpretation in light of the Tradition and Concepts
- Policy motions presented to the 2017 World Service Conference (WSC)

Policy motions approved by the WSC

The following topics were discussed at the July 2017 Policy Committee meeting: Group Autonomy: Tradition Four and Warranty Four discussion, which was started at the Open Policy meeting at the 2017 World Service Conference, continued.

Electronic Meetings discussion, started at the 2017 WSC Open Policy meeting, resulted in a thought force created to produce a KBDM for the July 2017 Policy Meeting.

The Policy Committee reviewed the KBDM and after a discussion decided to create a work group that will explore ways to reach out to electronic meetings and find ways to allow them to fully participate in the fellowship.

"Open" and "Closed" Terminology discussion continued. The Policy Committee agreed, by consensus, to remove the term "Closed" from the Policy Digest. The Policy Committee decided to wait for the report back from the "Policy Digest Thought Force" in October 2017 before deciding on the next steps to take.

As always, members of Al-Anon are encouraged to submit questions or shared experiences to the Policy Committee for more interpretation according to our basic guides, i.e., the Twelve Traditions and the Twelve Concepts of Service. Consider how this issue might affect worldwide Al-Anon as a whole, remembering that Al-Anon policies are simply interpretations according to principles and not rigid rules.

That is all for now my friends. Once again, I am so grateful for this opportunity to be your Delegate, it is such a wonderful experience! I urge you all to think about your next step in service as this panel draws to a close. The growth in my recovery has been enormous. If you have some twinges remember, as the old saying goes, "FEAR" = Face Everything and Recover!
