The AAPP serves as the Area's designated Alateen contact with the WSO Group Records Department regarding Alateen forms and processes all Alateen group and AMIAS information for the Area. The AAPP collaborates with the Area Alateen Coordinator and the Groups Records Coordinator...concerning the distribution and submission of Alateen forms and the WSO Group Records reports. (p. 75)

- **Recertification with the WSO.** We have successfully completed our Annual Recertification with the WSO. Thanks to all the members who are participating in service to Alateen, and especially for your cooperation and attention to details!
- **Please check our Alateen page on the Area Website** – all training information and required forms are there for you to prepare and participate!
- **Interested?** If you are interested in becoming an AMIAS please contact your District Representative or our Alateen Coordinator. It is possible for Districts to schedule online or in person FRESH events. Eleanor and I can help you coordinate that!
- **Alateen Groups:** We currently have **15 Registered Alateen Groups (with 1 pending)**
- **Certified AMIAS:** We currently have **67 Certified AMIAS**
- **FRESH Events:** In August we will be posting the upcoming 2024 FRESH Event Schedule for October 2023 through April 2024 which will be the time period for our WSO Recertification process. This will be handled by both our current Alateen Coordinator and AAPP as well as our future Panel 64 Alateen Coordinator and AAPP!

2024 Certification Forms will be uploaded to the Area Website along with the FRESH Event schedule.

PLEASE NOTE: ALL AREA AMIAS MUST GO THROUGH THE PROCESS OF CERTIFICATION DURING THIS WINDOW. AND ALL AREA AMIAS MUST HAVE A NEW BACKGROUND CHECK DONE DURING THIS WINDOW. (This is a requirement because we will be entering a new Panel!)

Forms and Requirements (all downloadable from our Area website through August):

- 1) Current **Area Safety and Behavioral Requirements**
- 2) Panel 61 **Area 9 2023 AMIAS Certification Form** - all AMIAS need to complete.
- 3) Panel 61 **Area 9 2023 Alateen Group Sponsor Form** - if you are a CMA or Group Sponsor
- 4) Current **VECHS Waiver Form** that needs to be filled out, *and the original mailed to the AAPP. Address is on the form.*
- 5) Instructions for getting a background check if you are a newly certifying AMIAS.

If you are an AMIAS in our Area, please stay in touch with me regarding any changes you make in your contact information. This is vital. Returned mail or bounced emails to the WSO will result in inactivation.

If you are a Group Sponsor: I need a current AREA 9 Alateen Group Sponsor Form for every group you sponsor. This needs to be filled out and updated each year so that the Area Recertification can proceed.
