### Overview

A motion will be made at the upcoming virtual AWSC for Area 9 to purchase a one-year subscription for a cloud-based video conference service on a trial basis.

## Platform Recommendation

My recommendation is to purchase Zoom's Business Plan which comes with 10 Host licenses. Zoom can be used across multiple devices (Mac, PC, and Chromebook as well as for Android and iOS). Members and participants do not need their own Zoom account to join a meeting. Zoom's website (<a href="www.zoom.com">www.zoom.com</a>) has a number of valuable training materials, including user guides and help videos.

## Zoom Meeting Business Plan Features (Selected Highlights)

- Unlimited Meetings: A Host can have unlimited meetings.
- Meeting Participants: Each meeting supports up to 300 participants.
- Meeting Time Limit: Each meeting can last up to 24 hours.
- **Polling:** Can create single choice or multiple choice polling questions.
- Cloud recording transcripts: Receive transcripts of meetings that are recorded in the cloud.
- Cloud Storage Per Month: 1 GB
- **Customer Support:** Web, chat, and dedicated phone support for Administrators.
