

8. Working knowledge of the Service Manual.




9. Working knowledge of the Steps, Traditions and Concepts.

 - 7. Event Chairs: Reports at the microphone.
 - 8. ***District Representatives ****
 Introduce their district members at the microphone and announce the number of voting and non-voting members in <u>attendance</u>.

13. Who Votes at Assembly? Who has a voice?


DR & DISL: Vote at AWSC meetings.
