- \$2,200 on fees for tables at professional conferences (\$2,200 is an estimate; funds may be used for print outs for registration packets at the conferences as well.)

The total requested for Public Outreach is \$3,500.00

We have the opportunity to place a copy of "Open Letter To Lawyers" in the registration bags for the Florida Bar Association Convention in Orlando June 13 - 16, 2018. Mental Health and wellness will be their focus at this years Annual Florida Bar Convention. We can have the Open Letter laced in 1,000 registration bags to \$750.00 and printing will cost approximately \$70.00. I will ship these to Cindy J who will deliver them to the Florida Bar. I have also placed Maps of the Florida Area Bar Associations in each AISL folder with the contact information. We would like to get a packet out to each local Bar Association with a copy of Al-Anon Faces Alcoholism, a pen, Open Letter to Lawyer, Understanding Ourselves and Alcoholism Understanding - (P-48), What To Do About the Alcoholic's Drinking? - (P-19), Fact Sheets for Professionals - (S-37ES). These fees are included in the recommendations above.

At our Public Outreach Table we have a display of outreach material. Also are extra copies of the Maps of the Florida Area Bar Associations.

I have asked each district to share their experience, Strength and Hope with projects tried in their district. There are copies of these on our table and these will be listed on our web page.

Going forward we would like input from each District on project ideas they would like to see at area level. I would like to have these no later than July 1, 2018. Our committee will take these ideas and take the top 3 and use these for our recommendations for Area 9 Public Outreach 2019.
